

The 16 th CONTEST OF YOUNG PIANISTS
School of Music „Mihailo Vukdragovic“ Sabac

Propositions

Article 1.

The 16 th Contest of young pianists will be held in Sabac from 1 st to 5 th March 2012. School of Music „Mihailo Vukdragovic“ Sabac is the Contest organizer. Manager of the contest is head master of School of Music. Manager of the Contest appoints members of Organizing Committee of the Contest.

Article 2.

Members of the jury of the Contest are eminent domestic and foreign teachers, appointed by Organizing Committee of the Contest.

Article 3.

The Contest is public and participation is allowed to every regular and extramural student of Primary and Secondary School of Music , Music Academy, conservatory from Serbia and abroad.

Article 4.

The Contest will include the following categories:

Pre-category: born in 2003 and younger –up to 5 min. programme

I category: born in 2001 and younger – up to 8 min. programme

II category: born in 1999 and younger – up to 12 min. programme

III category: born in 1997 and younger – up to 15 min. programme

IV category: born in 1995 and younger – up to 18 min. programme

V category: born in 1993 and younger – up to 20 min. programme

VI category: music academy basic level non-graduates – up to 30 min. programme

Jury is allowed to stop the performance of a participant if it lasts longer than it is supposed.

Article 5.

The participants of the contest will perform :

Pre-category will include following programme : free programme up to set time limit

I,II , III, IV, and V category will include the following programme:

Free programme up to the time limits previously mentioned per each category, which would contain at least two pieces of different style (work from the classical period is required).

VI category will include following programme:

1st movement of sonata or concert and free programme up to the set time limit for category which would contain at least two pieces of different style.

The programme will be performed by heart.

Article 6.

The deadline to apply for the competition is the 25th January 2012. You can send an application form to the following address:

Article 7.

Together with the application form the participants have to send a copy of birth certificate or a copy of a passport, the confirmation of attending the certain year at academy of music for 6th category only, colour passport photograph 3,5 x 4,5 cm (available by e-mail, also) and the proof of given donation of the expenses for the participation in Contest.

Article 8.

The donation for participation for foreign participants is 50 € each, could be paid after applying for the contest, according to the way set by Organizer.

In case of canceling the participation the contest, the donation would not be withdrawn.

Article 9.

The winner in each category would be awarded the Trophy and the money prize. The title of laureate of the competition can be awarded to the winner of the III ,IV ,V and VI category and to the winner in the precategory, I and II category . The winner of the Contest in younger category is allowed to participate again, having a chance to win again only in the older category. The winner of the Contest in older category is allowed to participate the Contest again, knowing that it is not possible to win again. The title of the winner of the category is assigned to one competitor only. In case of equal scores, the younger competitor is declared to be a winner of the Contest.

Article 10.

Scores:

95,00 -100,00 points for the 1st prize

85,00 -94,99 points for the 2nd prize

75,00 -84,99 points for the 3rd prize

65,00 -74,99 points of commendation

Article 11.

The travel expenses and hotel bills are to be paid by the participants of the Contest.

Article 12.

The organizer maintains of all rights reserved for recording, distributing and broadcasting the programme, without the possibility for contestants to get paid for recording of their performances of any kind. Recordings are permanent property of the Organiser of the Contest.

Article 13.

The winners have an obligation to be available to the Organiser of the Contest in case necessity of broadcasting or recording during and after the Contest, for free.

Article 14.

Signature on application form for the Contest is to accept all conditions and obligations of the Contest propositions.
